Terms and Conditions

1. Exclusive Photographer. The Photographer shall be the exclusive photographer retained by the Client for the purpose of photographing the wedding. Family and friends of the Client shall be permitted to photograph the wedding as long as they shall not interfere with the Photographer's duties.
2. Deposit and Payment. The Client shall make a \$250 deposit to retain the Photographer to perform the services specified herein. The deposit shall be applied to reduce the total cost and Client shall pay the balance no later than 5 days before the day of the event.
3. Cancellation. If the Client shall cancel this Agreement all deposits will be non-refundable and retained by the photographer.
4. Copyright and Reproductions. The Photographer shall own the copyright in all images created and shall have the right to make reproductions. The Photographer shall only make reproductions for the Client or for the Photographer's portfolio, samples, self-promotions, entry in photographic contests or art exhibitions. Client will also have copyright on all images to be printed as client wishes.
5. Client's Usage. The Client is obtaining prints for personal use only, and shall not sell said prints or electronic images.
6. Failure to Perform. If the Photographer cannot perform this Agreement due to a fire or other casualty, strike, act of God, or other cause beyond the control of the parties, or due to Photographer's illness, then the Photographer shall return the deposit to the Client but shall have no further liability with respect to the Agreement. This limitation on liability shall also apply in the event that photographic materials are damaged in processing, lost through camera malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of the Photographer. In the event the Photographer fails to perform for any other reason, the Photographer shall not be liable for any amount in excess of the retail value of the Client's order.
7. Photographer. The Photographer may substitute another photographer to take the photographs in the event of Photographer's illness. In the event of such substitution, Photographer warrants that the photographer taking the photographs shall be a competent professional.
8. Inherent Qualities. Client is aware that color dyes in photography may fade or discolor over time due to the inherent qualities of dyes, and Client releases Photographer from any liability for any claims whatsoever based upon fading or discoloration due to such inherent qualities.
9. Photographer's Standard Price List. The charges in this Agreement are based on the Photographer's Standard Price List. This price list is adjusted periodically and future orders shall be charged at the prices in effect at the time when the order is placed.
10. Arbitration. All disputes arising under this Agreement shall be submitted to binding arbitration. Notwithstanding the foregoing, either party may refuse to arbitrate when the dispute is for a sum less than \$800.00.
11. Miscellany. This Agreement incorporates the entire understanding of the parties. Any modifications of this Agreement must be in writing and signed by both parties. Any waiver of a breach or default hereunder shall not be deemed a waiver of a subsequent breach or default of either the same provision or any other provision of this Agreement. This Agreement shall be governed by the laws of the State of Washington.
12. Event Photography. Often times, the celebrant of the event will disallow photographs during the actual wedding event, or will disallow the use of photo flash during the event. It is the responsibility of the Client to inquire with the celebrant, the rules and requirements during the event and communicate them with the Photographer prior to the event. If photo flash is required for a quality photograph, but disallowed by the celebrant, either existing light photographs will be taken which may greatly decrease the overall quality of the image, or the event can be staged either before or after the actual event as agreed upon in advance.
